SECTION 7: Handling and storage**7.1. Precautions for safe handling**

Avoid skin contact with hot material. This product is considered to be an article which does not release or otherwise result in exposure to a hazardous chemical under normal use conditions. Do not eat, drink or smoke when using this product. Wash thoroughly after handling. Dust clouds of this material in sufficient concentration in combination with an ignition source may be explosive. Dust deposits should not be allowed to accumulate on surfaces because of the potential for secondary explosions. Routine housekeeping should be instituted to ensure that combustible dusts do not accumulate on surfaces. Solids can generate static electricity charges when transferred and in mixing operations sufficient to be an ignition source.
